Position Overview:

The Young Adult Team Coordinator is a peer-led position designed to empower rural young adults in fostering a mindset of volunteerism, leadership, and community engagement. With the support of the Ledge staff, the coordinator will form and lead teams of young adults, guiding them through a research-driven approach to understand the assets and needs of their peers and develop events, initiatives, and service projects that encourage volunteer participation.

This is a dynamic and hands-on role ideal for a young adult passionate about community building, leadership development, and peer engagement. The position offers an opportunity to make a meaningful impact while gaining valuable experience in volunteer coordination, event planning, and social impact work.

Key Responsibilities:

- 1. **Team Formation** (in partnership with Ledge staff)
 - Create supporting information to generate interest in the young adult volunteer team
 - Design and implement a recruitment process to draw young adults to join a volunteer team to engage them in community-based projects

2. Team Leadership

- · Foster a collaborative and inclusive team culture
- Oversee the team's work through peer research and event planning
- Support participants in developing their own leadership and service mindset

3. Communication & Reporting

- Maintain regular communication with young adult team members and the Co-Executive Directors
- Provide regular reports on team progress and volunteer hours to the Co-Executive Directors

4. Ledge Team Engagement

- Participate in regular meetings virtually or in-person with the Co-Executive Directors
